- 3) The insurance of equipments, computers, machinery and furniture/fixture is not done.
- 4) The expenditure is incurred with reference to the budget allocation approved by the NACO. The actual expenditure has not exceeded the budget allocation.
- 5) No personal expenditure of employees/officers has been charged to Expenditure accounts
- 6) The back up of accounting data is taken periodically by the Society and kept separately.
- 7) There is no system of obtaining the balance confirmation of advances. The balance confirmation is necessary where the advances are outstanding for more than one year. The advances which are pending for more than one year should be adjusted.
- 8) The reconciliation of bank statement is regularly carried on a monthly basis.
- 9) There is delay in the deposit of Provident Fund.
