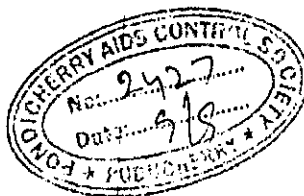

ORDER

0. THE SECRETARY, SECRETARIAT

Rules for grant of Financial Assistance to the Members of Scheduled Castes patient suffering from prolonged diseases:

1. Short title, extent and commencement -

- (i) These rules may be called Government of Pondicherry. Grant of Financial Assistance to Scheduled Caste patient suffering from prolonged diseases, Rules, 2001.
- (ii) They shall extend to the entire Union Territory of Pondicherry.
- (iii) They shall come into force from the date of their publication in the official gazette.

2. Objective of the Scheme -

The objective of the scheme is to provide financial assistance to the Scheduled Caste members who are unable to work for their earning due to prolonged diseases.

3. Definition -

In these rules, unless the context otherwise requires:

- (i) "Chief Medical Officer" means the Chief Medical Officer of Karaikal, Mahe or Yanam regions as the case may be.
- (ii) "Department" means Adi-Dravidar Welfare Department.
- (iii) "Director" means the Director of Adidravadar Welfare Department.
- (iv) "Government" means the Administrator of the Union Territory of Pondicherry appointed by the President under article 239 of the Constitution.
- (v) "Medical Officer" means the Medical Officer-in-Charge of Community Health Centre/Primary Health Centre or Dispensaries located in the various parts of the Union Territory of Pondicherry.
- (vi) "Medical Superintendent" means the Medical Superintendent of the Government General Hospital, Pondicherry or any Recognised Hospital outside the Union Territory of Pondicherry to which the patient is referred to.
- (vii) "Prolonged Diseases" means the disease as listed in the annexure, which require long period of continuous treatment for recovery, to be certified by the authorised Medical officer.
- (viii) "Scheduled Caste" means the caste which have been so declared in relation to the union Territory of Pondicherry under article 341 of the Constitution.

4. Eligibility and condition -

The Financial Assistance under the Scheme shall be granted to Scheduled Caste Members -

- (i) Who belong to Scheduled Caste Community of the Union Territory of Pondicherry by virtue of his/her continuous residence for not less than five years.
- (ii) Whose annual income from all sources should not exceed Rs. 15,000/-
- (iii) Who are unable to go for his/her work for earning due to continuous treatment owing to prolonged diseases listed in the annexure.
- (iv) The applicant should have completed 18 years of age as on date of application.

5. Nature of Assistance -

A Scheduled Caste patient who fulfills the eligibility conditions will be given Rs.300/- as Financial Assistance every month till recovery of his/her illness. Every six months, the beneficiaries shall be asked to produce a certificate obtained from the Medical Officer regarding progress of his/her health condition. On the basis of certificate the Director shall decide whether to continue the assistance to the applicants beyond this period or otherwise.

6. How to apply for the assistance -

- (i) The application for financial assistance under this rule shall be made in Form I appended to these rules.
- (ii) The applications shall be accompanied by a Medical Certificate in Form II appended to these rules, obtained from the prescribed Medical Officer.
- (iii) The applications shall be accompanied by a Certificate issued by Deputy Tahsildar/Tahsildar certifying the caste, income and Residence of the applicant in Form - III appended to these rules.
- (iv) Persons competent to issue Medical Certificate under Rule 5. -

In addition to the Director of Health & Family Welfare Service, Medical Superintendent and Chief Medical Officers concerned, the following persons shall be competent to issue medical Certificate under these rules viz., Medical Officer in charge of Community Health Centre, Primary Health Centre, Health Centre/any other Peripheral Health Centre of this Union Territory.

ANNEXURE

THE FOLLOWING DISEASE SHALL BE CONSIDERED FOR FINANCIAL ASSISTANCE.

- I. Carcinome when the patient is treated and cannot perform his work for more than four weeks.
- II. Medicines
Tuberculosis: Pulmonary or extra-pulmonary paralysis of muscles of extremities
Motor neurone disease
Severe neurological disorders
Pleural effusion
Pericardial effusion
Infective hepatitis
Cirrhosis of liver with Ascitis and Oedema legs and other chronic diseases like diabetes Mellitis & Hypertension.
- III. Nephrology
Renal failure
Calculi/Stricture Ureter/Urethra
Enlarged Prostate
Nephrotic syndrome
Chronic Nephritis
- IV. EYE
Cataract where visual impairment is more to interfere with the working capacity
Retinal disorders with loss of vision
- V. Skin ✓
Hansen Disease with trophic ulcer and nerve paralysis interfering with his working capacity.
Pemphigus/Bullous Pemphigoid
- VI. Cardiology ✓
Rheumatic Heart disease, Severe Hypertension with congestive cardiac failure
Coronary insufficiency
Aneurysm of Aorta Poli coronary by pass state
- VII. Orthopaedics ✓
Bone Fractures, Dislocation of joint with immobilisation of more than four weeks.
Ligamental tear/Arthritis-where individual is treated for more than four weeks
- VIII. Surgery ✓
Elective/Emergency Surgeries involving admission and bed rest of more than four weeks.
Head injuries with sequelae
Burns/scalds/soft tissue injuries where incapacitation is more than four weeks.
- IX. Any other disease where the individual is incapacitated and unable to work for more than one month.

**RULES FOR THE "FINANCIAL ASSISTANCE TO
HIV/AIDS AFFECTED PEOPLE"**

1. SHORT TITLE, APPLICATION AND COMMENCEMENT:-

- (1) These rules may be called the "Financial Assistance to HIV/AIDS Affected People Rules, 2015"
- (2) They shall apply to the whole of the Union Territory of Puducherry.
- (3) They shall come into force on and from the date of their publication in the Official Gazette.

2. DEFINITIONS:-

In these rules, unless the context otherwise requires:-

- (a) "Appellate Authority" means the Secretary to Government in-charge of the Department;
- (b) "Assistance" means the financial assistance granted under these rules;
- (c) "Director" means the Director to Government in-charge of the Department;
- (d) "HIV/AIDS Affected People" means a person who is infected by HIV /affected by AIDS taking treatment in the ART (Anti Retroviral Therapy) centre, who cannot be rehabilitated otherwise than by grant of financial assistance under these rules
- (e) "Form" means Form appended to these rules;
- (f) "Government" means the Administrator of the UT of Puducherry appointed under article 239 of the Constitution of India;
- (g) "Sanctioning Authority" means the Director of Women and Child Development;
- (h) "Union Territory" means the Union Territory of Puducherry

3. GRANT OF FINANCIAL ASSISTANCE:-

Subject to the provision of Rule 4, assistance may be granted to a person affected by HIV/AIDS of an amount of Rs.1500/- per month upto 59 years of age, Rs.2000/- between the age group 60-79 and Rs.3000/- for 80 years and above .

(i) Eligibility:

A person affected by HIV/AIDS shall satisfy the following requirements for eligibility for assistance, namely;-

- (a) He /She /Transgender must be a resident of U.T. of Puducherry at the time of making application for the grant of assistance;
- (b) He/She Transgender should be a registrant in the ART Centre, IGMC & RI, Puducherry/Link ART centre JIPMER in respect of Puducherry region, ART centre, Nagapattinam in respect of Karaikal region, ART Centre, Calicut in respect of Mahe region, ART Centre, Kakinada in respect of Yanam region and taking regular treatment & any other ART/Link ART Centres to be established in future in the UT of Puducherry.

(ii) TENURE OF THE GRANT

- (a) Assistance to the person affected by HIV/AIDS once sanctioned will be tenable for the period for which the recipient is alive or for 10 years whichever is earlier subject, however, to renewal if the person affected by HIV/AIDS is alive beyond the period of 10 years and continues to satisfy the conditions of eligibility specified in Para-4 :

Provided that nothing in this rule shall preclude the sanctioning authority from reviewing at any time the case of the person affected by HIV/AIDS under any changed circumstances arising subsequent to the sanctioning of the assistance and withdraw or reduce the quantum of assistance :

Provided further that the person affected by HIV/AIDS or his/her parent or guardian, as the case may be, and shall be given an opportunity of being heard before the assistance is withdrawn or reduced.

- (b) If the grantee dies before receiving the assistance for any period, the same shall lapse.

4. HOW TO APPLY

- (1) The application for assistance shall be made in Form-I by the person affected by HIV/AIDS or by either of his/her parent or guardian, if the applicant is minor or mentally retarded person or a spastic child.
- (2) Application forms can be had from the Department of Women and Child Development for Puducherry region, from the Deputy Director, Karaikal region, from the Welfare Officer, Mahe and Yanam for Mahe and Yanam regions respectively or can be downloaded from the Department of Women and Child Development website.
- (3) The filled applications shall be submitted direct to the respective officers noted at Sub- para (2) above by whom the applications were issued.
- (4) The applications shall be submitted along with the following certificates:
- (a) Registration/treatment certificate issued by the ART Medical Officer concerned.
- (b) Any one of the following residence proof
- Voter- ID
 - Ration Card
 - Passport
 - Driving License
 - Certificate issued by NGO/Gazetted Officer

5. SCRUTINY OF APPLICATION

On receipt of the application, the respective ART Medical Officer/Link ART centre will scrutinize the application, verify the registration at their centres and forward the application to the respective Medical Superintendent/Deputy Director attached to Govt. General Hospitals together with their recommendations for Countersignature by the respective authorities as detailed below:

The countersigned application will then be forwarded to the Director, Department of Women and Child Development through Project Director PACS for sanction of relief. The Medical Officer (I/c) of the ART/Link ART centre shall have to submit monthly report containing the details of persons affected by HIV/AIDS to the Director, DWCD, Puducherry.

6. SANCTION OF ASSISTANCE

After having satisfied that the applicant is eligible for the assistance under these rules, the Director, DWCD may sanction the assistance to the applicant.

7. MODE OF PAYMENT

The monthly payment shall be directly deposited with the Bank A/C of the beneficiary. The assistance shall become due for payment only on the expiry of the month to which it relates, and the amount of assistance shall become payable from the first of month in which it is sanctioned.

8 INTIMATION OF CHANGE OF ADDRESS .-

It shall be obligatory for a grantee of assistance to intimate any change of address to the respective Medical Officer, ART Centre/Link ART Centre. The person shifting to a place outside the UT for a period exceeding three months shall not be eligible for the assistance. The order sanctioning assistance shall be cancelled if the grantee is absent from the UT for more than three consecutive months.

Provided that, if the grantee returns to the UT at any time and continues to reside in the UT, the Director, DWCD may revive the payment of assistance after due verification of the facts relevant to the continuance of the assistance and the arrear of assistance shall also be paid in such cases subject to a maximum of three months.

9 CANCELLATION . -

Notwithstanding anything contained in Rule 5, the Director, DWCD may cancel the sanction issued for grant of assistance and stop the payment of assistance, if at any stage, it is found that it was sanctioned on a mistaken ground or on false information and recover the entire amount of assistance paid to the grantee till such cancellation.

10 POWER OF SUPERVISION .-

(i) The Director, DWCD shall ensure that the provisions of these rules are strictly complied with and is competent to issue instructions subject to which the assistance should be granted or continued and the person affected by HIV/AIDS or his/her parent or guardian shall be bound by such instructions.

(ii) Where it appears that a parent or guardian of the person affected by HIV/AIDS does not look after the person affected by HIV/AIDS, the Director, DWCD may suspend payment of assistance until alternative arrangements are made for the care and support of the person affected by HIV/AIDS whereafter the entire assistance withheld may be released in favour of the person affected by HIV/AIDS.

11 APPEAL .-

- (i) Any person aggrieved by any decision or order of the Director, DWCD under these rules, may file and appeal to the Appellate Authority, whose decision on the appeal shall be final :
- (ii) The appeal under sub-rule(1) shall be filed within three months from the date of the decision or order appealed against.

Provided that the Appellate Authority may entertain an appeal after the expiry of the said period of three months on sufficient grounds being shown by the applicant as to why he/she was precluded from filing an appeal within the specified period.

12 INTERPRETATION .-

If any doubt arises as to the interpretation of these rules, the matter should be referred to Secretary to Government and the decision of the Secretary shall be final.

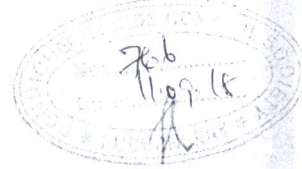

**RULES FOR "THE GRANT OF TRANSPORTATION CHARGES TO THE PEOPLE
LIVING WITH HIV/AIDS"**

1. SHORT TITLE, APPLICATION AND COMMENCEMENT:-

- (i) These rules may be called the "The Grant of Transportation Charges to the People Living with HIV/AIDS Rules, 2018".
- (ii) They shall apply to the whole of the Union Territory of Puducherry.
- (iii) They shall come into force on and from the date of their publications in the Official Gazette.

2. OBJECTIVE OF THE SCHEME:-

The object of the scheme is to provide the minimum transportation charges incurred by the People Living with HIV/AIDS for attending ART (Anti Retroviral Therapy) Centre for collecting ART drugs and to get treatment

3. DEFINITIONS:-

In these rules, unless the context otherwise requires:-

- (a) "Appellate Authority" means the Secretary to Government (Health), Government of Puducherry;
- (b) "Director" means the Director, Health and Family Welfare Department, Puducherry;
- (c) "Form" means Form appended to this scheme;
- (d) "Government" means the Administrator of the Union Territory of Puducherry appointed under article 239 of the Constitution of India;
- (e) "Grant of Transportation Charges" means the financial assistance granted under these scheme;
- (f) "People Living with HIV/AIDS " means a person who is infected by HIV/AIDS taking treatment in the ART (Anti-Retroviral Therapy) centre, who cannot be rehabilitated otherwise than by grant of financial assistance under these scheme;
- (g) "Union Territory" means the Union Territory of Puducherry.

4. GRANT OF TRANSPORTATION CHARGES:-

Subject to the provision of Rule 7, transportation Charges will be granted to the People Living with HIV/AIDS in order to ensure their better treatment and adherence to treatment with the following rate at Region wise:-

- (a) Puducherry & Karaikal region will be given a sum of Rs.100/- (Rupees one hundred only) for every quarters;
- (b) Mahe and Yanam Region will be given a sum of Rs.200/- (Rupees two hundred only) for every quarters;

5. **ELIGIBILITY:-**

A Person Living with HIV/AIDS shall satisfy the following requirements for eligibility for assistance, namely:-

- (a) He /She /Transgender must be a resident of Union Territory of Puducherry at the time of making application of assistance;
- (b) He / She Transgender should be a registrant with the following ART Centre:-

6. **TENURE OF THE GRANT:-**

- (a) The Grant of Transportation Charges to the Person affected by HIV/AIDS once sanctioned will be tenable for the period for which the recipient is alive or for 10 years whichever is earlier. If the person affected by HIV/AIDS is alive beyond the period of 10 years and continues to satisfy the conditions of eligibility specified in Para-5;

Provided that nothing in this rule shall preclude the sanctioning authority from reviewing at any time the case of the person affected by HIV/AIDS under any changed circumstances, arising subsequent to the sanctioning of the assistance and withdraw or reduce the quantum of assistance;

Provided further that the person affected by HIV/AIDS or his/her parent or guardian, as the case may be, and shall be given an opportunity of being heard before the assistance is withdrawn or reduced.

- (b) If the beneficiary dies before receiving the assistance at any period, the same shall be lapsed.

7. **HOW TO APPLY:-**

- (1) An application for getting transportation charges shall be made in Form-I (Annexure) by the person affected by HIV/AIDS or by either of his/her parent or guardian, if the applicant is minor or mentally retarded person or a spastic child.
- (2) The applications duly filled in by the applicant shall be submitted directly to the respective officers noted in the following table, by whom the application was issued.

Mahe	The Medical Officer I/c., ART Centre, Calicut, Kerala.
Yanam	The Medical Officer I/c., ART Centre, Kakinada, Andhra Pradesh.

(3) The received application shall be countersigned by the Project Director, Pondicherry AIDS Control Society for sanction.

(4) The applications shall be submitted along with the following certificate:-

- a. Registration/treatment certificate issued by the ART (Anti Retroviral Therapy) Medical Officer concerned;
- b. The Copy of the residence proof (anyone available) issued by the concerned Authority;
- c. Copy of the Bank Passbook.

8. **SCRUTINY OF APPLICATION:-**

(i) On receipt of the application, the respective ART Medical Officer/Link ART centre will scrutinize the application, verify the registration at their centres and forward the application to the Project Director, Pondicherry AIDS Control Society for sanction of the transportation charges.

(ii) The Medical Officer (I/c) of the ART/Link ART centre shall have to submit monthly report containing the details of persons affected by HIV/AIDS to the Project Director, Pondicherry AIDS Control Society, Puducherry.

9. **SANCTION OF ASSISTANCE:-**

After having satisfied that the applicant is eligible for the assistance under these rules, the Project Director, Pondicherry AIDS Control Society may sanction the assistance to the applicant.

10. **MODE OF PAYMENT:-**

The provision of Transportation Charges shall be directly deposited with the Bank A/C of the beneficiary for every quarter or yearly once. The amount of assistance shall become payable from the first month in which it is sanctioned. Further, the payment to person living with HIV (PLHIV) will be made subject to verification by Project Director, Puducherry AIDS Control Society that patient regularly attend the ART centre and received treatment/consultation/counseling.

11. **INTIMATION OF CHANGE OF ADDRESS:-**

It shall be obligatory for a beneficiary of assistance to intimate any change of address to the respective Medical Officer, ART Centre/Link ART Centre. The person shifting to a place outside the Union territory of Puducherry for a period exceeding three months shall not be eligible for the assistance. The order sanctioning assistance shall be cancelled if the beneficiary is absent from the Union territory of Puducherry for more than three consecutive months;

Provided that, if the beneficiary returns to the Union territory of Puducherry at any time and continues to reside in the Union territory of Puducherry, the Project Director, Pondicherry AIDS Control Society may revive the payment of assistance after due verification of the facts relevant to the continuance of the assistance and the arrear of assistance shall also be paid in such cases subject to a maximum of three months.

12. **CANCELLATION:-**

Notwithstanding anything contained in Rule 8, the Project Director, Pondicherry AIDS Control Society may cancel the sanction issued for grant of assistance and stop the payment of assistance, if at any stage, it is found that it was sanctioned on a mistaken ground or on false information and recover the entire amount of assistance paid to the beneficiary till such cancellation.

13. **APPEAL:-**

1. Any person aggrieved by any decision or order of the Project Director, Pondicherry AIDS Control Society under these scheme, may file an appeal to the Appellate Authority, whose decision on the appeal shall be final;
2. The appeal under sub-rule (1) shall be filed within three months from the date of the decision or order appealed against;

Provided that the Appellate Authority may entertain an appeal after the expiry of the said period of three months on sufficient grounds being shown by the applicant as to why he/she/transgender was precluded from filing an appeal within the specified period.

14. **INTERPRETATION:-**

If any doubt arises as to the interpretation of these rules, the matter should be referred to Secretary to Government (Health), Government of Puducherry and the decision of the Secretary shall be final.

2. DEFINITIONS:-

In these rules, unless the context otherwise requires:-

- (a) "Appellate Authority" means the Secretary to Government in-charge of the Department;
- (b) "Assistance" means the financial assistance granted under these rules;
- (c) "Director" means the Director to Government in-charge of the Department;
- (d) "HIV/AIDS Affected People" means a person who is infected by HIV /affected by AIDS taking treatment in the ART (Anti Retroviral Therapy) centre, who cannot be rehabilitated otherwise than by grant of financial assistance under these rules
- (e) "Form" means Form appended to these rules;
- (f) "Government" means the Administrator of the UT of Puducherry appointed under article 239 of the Constitution of India;
- (g) "Sanctioning Authority" means the Director of Women and Child Development;
- (h) "Union Territory" means the Union Territory of Puducherry

3. GRANT OF FINANCIAL ASSISTANCE:-

Subject to the provision of Rule 4, assistance may be granted to a person affected by HIV/AIDS of an amount of Rs.1500/- per month upto 59 years of age, Rs.2000/- between the age group 60-79 and Rs.3000/- for 80 years and above .

(i) Eligibility:

A person affected by HIV/AIDS shall satisfy the following requirements for eligibility for assistance, namely;-

- (a) He /She /Transgender must be a resident of U.T. of Puducherry at the time of making application for the grant of assistance;
- (b) He/She Transgender should be a registrant in the ART Centre, IGMC & RI, Puducherry/Link ART centre JIPMER in respect of Puducherry region, ART centre, Nagapattinam in respect of Karaikal region, ART Centre, Calicut in respect of Mahe region, ART Centre, Kakinada in respect of Yanam region and taking regular treatment & any other ART/Link ART Centres to be established in future in the UT of Puducherry.

(ii) TENURE OF THE GRANT

- (a) Assistance to the person affected by HIV/AIDS once sanctioned will be tenable for the period for which the recipient is alive or for 10 years whichever is earlier subject, however, to renewal if the person affected by HIV/AIDS is alive beyond the period of 10 years and continues to satisfy the conditions of eligibility specified in Para-4 :

Provided that nothing in this rule shall preclude the sanctioning authority from reviewing at any time the case of the person affected by HIV/AIDS under any changed circumstances arising subsequent to the sanctioning of the assistance and withdraw or reduce the quantum of assistance :

Provided further that the person affected by HIV/AIDS or his/her parent or guardian, as the case may be, and shall be given an opportunity of being heard before the assistance is withdrawn or reduced.

- (b) If the grantee dies before receiving the assistance for any period, the same shall lapse.

4. HOW TO APPLY

- (1) The application for assistance shall be made in Form-I by the person affected by HIV/AIDS or by either of his/her parent or guardian, if the applicant is minor or mentally retarded person or a spastic child.
- (2) Application forms can be had from the Department of Women and Child Development for Puducherry region, from the Deputy Director, Karaikal region, from the Welfare Officer, Mahe and Yanam for Mahe and Yanam regions respectively or can be downloaded from the Department of Women and Child Development website.
- (3) The filled applications shall be submitted direct to the respective officers noted at Sub- para (2) above by whom the applications were issued.
- (4) The applications shall be submitted along with the following certificates:
- (a) Registration/treatment certificate issued by the ART Medical Officer concerned.
- (b) Any one of the following residence proof
- Voter- ID
 - Ration Card
 - Passport
 - Driving License
 - Certificate issued by NGO/Gazetted Officer

5. SCRUTINY OF APPLICATION

On receipt of the application, the respective ART Medical Officer/Link ART centre will scrutinize the application, verify the registration at their centres and forward the application to the respective Medical Superintendent/Deputy Director attached to Govt. General Hospitals together with their recommendations for Countersignature by the respective authorities as detailed below:

The countersigned application will then be forwarded to the Director, Department of Women and Child Development through Project Director PACS for sanction of relief. The Medical Officer (I/c) of the ART/Link ART centre shall have to submit monthly report containing the details of persons affected by HIV/AIDS to the Director, DWCD, Puducherry.

6. SANCTION OF ASSISTANCE

After having satisfied that the applicant is eligible for the assistance under these rules, the Director, DWCD may sanction the assistance to the applicant.

7. MODE OF PAYMENT

The monthly payment shall be directly deposited with the Bank A/C of the beneficiary. The assistance shall become due for payment only on the expiry of the month to which it relates, and the amount of assistance shall become payable from the first of month in which it is sanctioned.



8 INTIMATION OF CHANGE OF ADDRESS .-

It shall be obligatory for a grantee of assistance to intimate any change of address to the respective Medical Officer, ART Centre/Link ART Centre. The person shifting to a place outside the UT for a period exceeding three months shall not be eligible for the assistance. The order sanctioning assistance shall be cancelled if the grantee is absent from the UT for more than three consecutive months.

Provided that, if the grantee returns to the UT at any time and continues to reside in the UT, the Director, DWCD may revive the payment of assistance after due verification of the facts relevant to the continuance of the assistance and the arrear of assistance shall also be paid in such cases subject to a maximum of three months.

9 CANCELLATION . -

Notwithstanding anything contained in Rule 5, the Director, DWCD may cancel the sanction issued for grant of assistance and stop the payment of assistance, if at any stage, it is found that it was sanctioned on a mistaken ground or on false information and recover the entire amount of assistance paid to the grantee till such cancellation.

10 POWER OF SUPERVISION .-

(i) The Director, DWCD shall ensure that the provisions of these rules are strictly complied with and is competent to issue instructions subject to which the assistance should be granted or continued and the person affected by HIV/AIDS or his/her parent or guardian shall be bound by such instructions.

(ii) Where it appears that a parent or guardian of the person affected by HIV/AIDS does not look after the person affected by HIV/AIDS, the Director, DWCD may suspend payment of assistance until alternative arrangements are made for the care and support of the person affected by HIV/AIDS whereafter the entire assistance withheld may be released in favour of the person affected by HIV/AIDS.

11 APPEAL .-

(i) Any person aggrieved by any decision or order of the Director, DWCD under these rules, may file and appeal to the Appellate Authority, whose decision on the appeal shall be final :

(ii) The appeal under sub-rule(1) shall be filed within three months from the date of the decision or order appealed against.

Provided that the Appellate Authority may entertain an appeal after the expiry of the said period of three months on sufficient grounds being shown by the applicant as to why he/she was precluded from filing an appeal within the specified period.

12 INTERPRETATION .-

If any doubt arises as to the interpretation of these rules, the matter should be referred to Secretary to Government and the decision of the Secretary shall be final.

**RULES FOR THE “FINANCIAL ASSISTANCE TO
HIV/AIDS AFFECTED PEOPLE”**

1. *Short title, application and commencement.*— (1) These rules may be called the “Financial Assistance to HIV/AIDS affected people Rules, 2015.”

(2) They shall apply to the whole of the Union territory of Puducherry.

(3) They shall come into force on and from the date of their publication in the Official Gazette.

2. *Definitions.*— In these rules, unless the context otherwise requires:-

(a) “Appellate Authority” means the Secretary to Government in-charge of the Department;

(b) “Assistance” means the financial assistance granted under these rules;

(c) “Director” means the Director to Government in-charge of the Department;

(d) “HIV/AIDS Affected People” means a person who is infected by HIV/affected by AIDS taking treatment in the ART (Anti Retroviral Therapy) Centre, who cannot be rehabilitated otherwise than by grant of financial assistance under these rules.

(e) “Form” means a form appended to these rules;

(f) “Government” means the Administrator of the Union territory of Puducherry appointed under Article 239 of the Constitution of India;

(g) “Sanctioning Authority” means the Director of Women and Child Development;

(h) “Union Territory” means the Union territory of Puducherry.

3. *Grant of financial assistance.*— Subject to the provision of Rule 4, assistance may be granted to a person affected by HIV/AIDS of an amount of ₹ 1,500 per month up to 59 years of age, ₹ 2,000 between the age group 60-79 and ₹ 3,000 for 80 years and above.

(i) Eligibility :

A person affected by HIV/AIDS shall satisfy the following requirements for eligibility for assistance, namely:-

(a) He/She/Transgender must be a resident of Union territory of Puducherry at the time of making application for the grant of assistance;

(b) He/She/Transgender should be a registrant in the ART Centre, IGMC and RI, Puducherry/Link ART Centre JIPMER in respect of Puducherry region, ART Centre, Nagapattinam in respect of Karaikal region, ART Centre, Calicut in respect of Mane region, ART Centre, Kakinada in respect of Yanam region and taking regular treatment and any other ART/Link ART Centres to be established in future in the Union territory of Puducherry.

(ii) Tenure of the grant:

(a) Assistance to the person affected by HIV/AIDS once sanctioned will be tenable for the period for which the recipient is alive or for 10 years whichever is earlier subject, however, to renewal if the person affected by HIV/AIDS is alive beyond the period of 10 years and continues to satisfy the conditions of eligibility specified in paragraph-4 :

Provided that nothing in this rule shall preclude the sanctioning authority from reviewing at any time the case of the person affected by HIV/AIDS under any changed circumstances arising subsequent to the sanctioning of the assistance and withdraw or reduce the quantum of assistance :

Provided further that the person affected by HIV/AIDS or his/her parent or guardian, as the case may be and shall be given an opportunity of being heard before the assistance is withdrawn or reduced.

(b) If the grantee dies before receiving the assistance for any period, the same shall lapse.

4. How to apply:

(1) The application for assistance shall be made in Form-I by the person affected by HIV/AIDS or by either of his/her parent or guardian, if the applicant is minor or mentally retarded person or a spastic child.

(2) Application forms can be had from the Department of Women and Child Development for Puducherry region, from the Deputy Director, Karaikal region, from the Welfare Officer, for Mahe and Yanam regions respectively or can be downloaded from the Department of Women and Child Development website.

(4) The applications shall be submitted along with the following certificates:

Family Ration Card

Passport

Driving Licence

Certificate issued by NGO/Gazetted Officer
